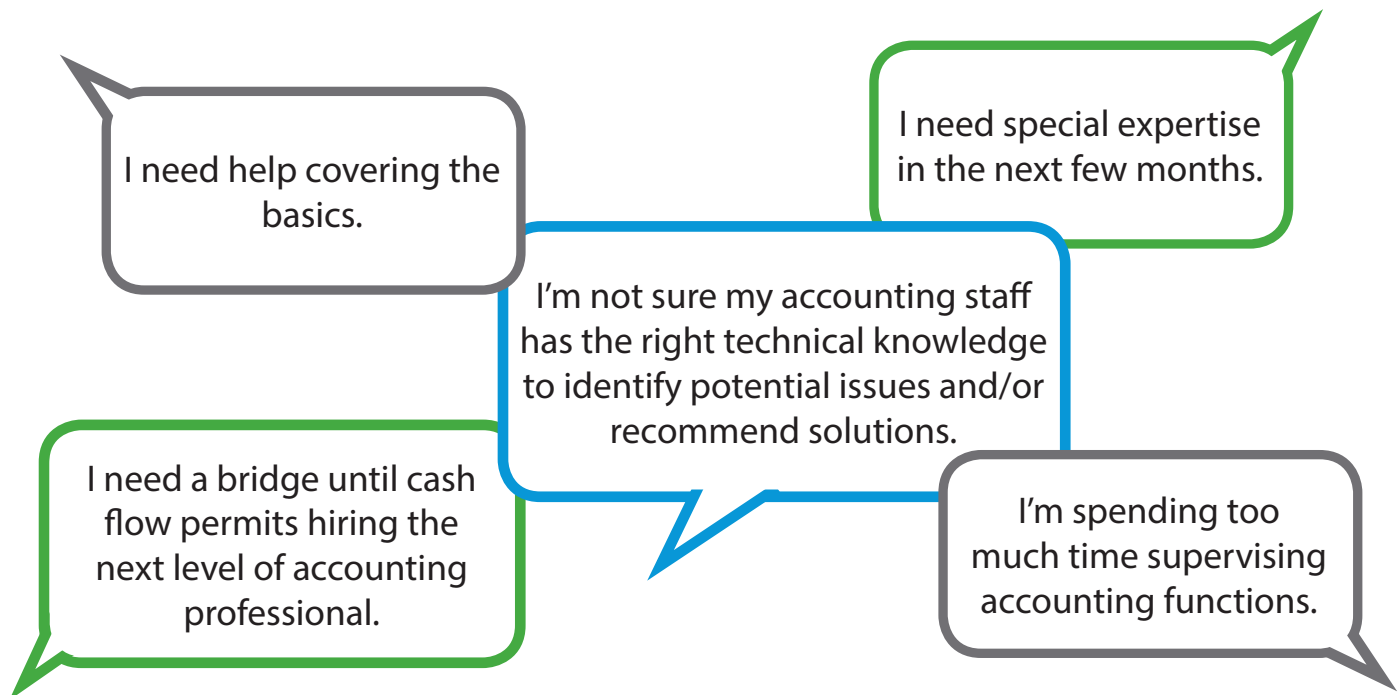


## Outsource Accounting Services
